Subject: Management of Parent Requests for Tuition and Other Fees - Institution Closed for Covid 19

1.General Position

The Lycée Louis Massignon, a direct management institution of the AEFE, applies the recommendations of the local authorities and the Fench Embassy. We are doing more tan our best to preserve the health of students and staff.

The local authorities closed all schools from 8 March to 4 April 2020 as follows: two weeks of leave for children from 08 to 21 March instead of 29 March to 12 April, and two weeks of distance work and e-learning from 22 March to 04 April.

Since the pedagogical continuity is ensured through the exceptional mobilization of teachers and all staff, applications for tuition rebates are not admissible under the local guidelines* and the AEFE requests

No, during this break, schools will continue to provide education in line with their academic plans. Schools have developed contingency plans and teachers are going to provide support to students during the two weeks of distance learning.
